SISTER CITY AGREEMENT

Between the TOWN OF QUEEN CREEK, ARIZONA, United States of America, and MUNICPALIDAD DE JESÚS MARIA, AGUASCALIENTES, Mexico

WHEREAS the Town of Queen Creek, Arizona, United States of America, and the city of Jesús Maria, Aguascalientes, Mexico, have designated each other as partners in an international friendship that promotes a great and mutual understanding between the cauzens of the United States and Mexico, and especially between the people of Queen Creek and Jesus Maria, and

WHEREAS Queen Creek and Jesus Maria are prosperous and progressive cities, they share much in common and both have the capacity to benefit by sharing their knowledge and experience with and learning from each other, and

WHEREAS the peace between the United States of America and Mexico is very valuable and appreciated and the joining of both lifestyles and cultures promotes peace and good understanding, and

WHEREAS economic development is the cornerstone of prosperity of Queen Creek and Jesús Maria, and the two cities desire to increase the commerce between them for their mutual benefit,

THEREFORE, Queen Creek and Jesús Maria desire to become Sister Cities and subscribe to the following.

Article I

The objective of this Sister Cities Agreement is to promote projects in the future, such as the sharing of knowledge between the two cities of Queen Creek and Jesús Maria, to promote Sisterhood always in the ways of peace, friendship, and a greater understanding between individuals.

Article II

To further the objective of the previous article, Queen Creek and Jesús Maria, promote the following.

- Cooperation with respect to knowledge, culture, art and customs.
 The exchange of knowledge in areas of municipal administration.
- Cooperation in areas of education exchanges of students, youths, and adults, including the public and private sectors.

Article III

In the exchange of experience and specialization in the administration of both cities, Queen Creek and Jesús Maria will carry out the following actions:

- To help solve the problems that surface between the Sister Cities, and also to influence those who are able to affect good relations between the United States and Mexico.
- To strengthen and promote the development between both cities, to sustain
 the present covenant and promote business between the Cities of Queen
 Creek and Jesus Maria.

Article IV

The details and program specifics not contained in the present Agreement will be established by mutual consent as to time and form.

Article V

For the exchange visits it is the responsibility of the sending agency, to pay all their expenses up to the port of entrance in the other country. The place that receives will be responsible to arrange events where culture and knowledge is promoted to the visiting delegation during the time of their visit.

Article VI

The duration of this agreement should be for an indef mite time period.

Article VII

In Queen Creek, Arizona, the Sister Cities Committee will be the agency responsible for the relation with Jesus Maria, Aguascalientes, Mexico. The address contact is:
