MEMORANDUM OF UNDERSTANDING AND COOPERATION BETWEEN THE DEPARTMENT OF PUBLIC EDUCATION OF THE STATE OF CHIHUAHUA AND THE UNIVERSITY OF TEXAS AT EL PASO

Whereas, considering the interest manifested by the government of Chihuahua, through Governor C. Patricio Martinez García and the disposition and commitment of the University of Texas at El Paso, through President Diana S. Natalicio;

Whereas, it is a priority for both entities to create, strengthen and provide impetus to the border as a shared development zone;

Whereas, education is a priority for the development of both nations; and

Whereas, the border cities of Ciudad Juárez and El Paso form the principal population center along the U.S.-Mexico border;

Therefore, be it agreed that the Department of Education and Culture of the State of Chihuahua and the University of Texas at El Paso sign this Memorandum of Understanding and Cooperation for the purpose of benefiting Mexican students who are residents of the State of Chihuahua pursuant to the terms and conditions specified below.

Commitments

The Department of Education and Culture of the State of Chihuahua, Mexico, will:

- invite state universities and public institutions of higher education of the State of Chihuahua to propose candidates to study at the Bachelor's, Master's and Doctoral levels in programs currently offered by the University of Texas at El Paso.
- propose fifty Mexican citizens with distinguished academic records each year to enter academic programs at UTEP.
- compensate UTEP for tuition costs as agreed in this Memorandum
- assist Mexican students who participate in the program in having their UTEP course work recognized when they return to Mexico

The University of Texas at El Paso will:

- offer the benefits of its Programa de Asistencia Estudiantil (PASE) to those students
 who are Mexican citizens and have been proposed by the Chihuahua Department of
 Education and Culture, who will then pay tuition at the same rates charged to Texas
 residents, in accordance with pertinent provisions and application procedures as
 established by the Legislature of the State of Texas.
- facilitate processing of UTEP application forms and academic records of those Mexican students proposed by the Department of Education and Culture of the State of Chihuahua.

Assist students in obtaining legal authorization from the necessary authorities for their stay in El Paso, Texas while they are enrolled at UTEP.

The terms and conditions of this Memorandum will be reviewed, evaluated and approved each year.

This agreement was read and the content and scope of each of its clauses understood by the contracting parties, who sign in duplicate in El Paso, Texas on June 5, 2001
