25th ANNUAL MEETING OF MEXICAN AMBASSADORS AND CONSULS

The 25th annual meeting of Mexican Ambassadors and Consuls was held in Mexico City from January 6-10, 2014 where federal and state government representatives, as well as international speakers also participated.

Mexican President Enrique Peña Nieto highlighted one his administration's foreign policy goals: "It is through you that the world may know about Mexico and what we are doing to achieve new and better horizons."

The President reaffirmed the five guiding principles of his government: to have a peaceful, inclusive, well- educated, prosperous and globally- responsible Mexico. He also stated the importance of the recent reforms put in place in order to reach those goals.

Furthermore, Foreign Secretary Jose Antonio Meade underlined the importance of promoting these latest reforms (fiscal, energy, telecommunications, etc.), which benefit Mexico and its citizens.

The bilateral relationship between Mexico and the United States also occupied an important part of the agenda. This relation is reflected in many ways, for example, trade: Mexico exports annually around 280 billion dollars. This amount represents 2.6 times the combined exports of Brazil, Russia, India and South Africa. In this context, the attendees expressed their commitment to foster Mexico's agenda with its North American partner.

The event brought the opportunity to exchange ideas between the participants and share their experiences in order to strengthen the assistance for Mexicans living abroad.

About 13 million dollars in goods are traded between the Grand Canyon State and Mexico, which exceeds the trade between Mexico and Central America.

In 2012 Mexico exported about 6 billion dollars and received 34% of Arizona's exports (\$6.2 billion usd), being computers and electronics the main goods. In addition, \$15 billion dollars in goods headed to other states cross through Arizona's ports of entry.

Regarding labor opportunities, more than 100 thousand jobs are directly related with trade with Mexico.

- With this Reform, it is expected that in 2018, domestic financing to the private sector is expected to equal 40% of GDP in 2018, which in 2012 was 25%
- The Reform will increase consumer spending and investment in Mexico, and it will increase almost 0.5% the annual economic growth between 2015 and 2018
- In 2013, credits from development banking institutions reached a trillion pesos. The goal is to reach 1 trillion 150,000 pesos in direct funding for 2014.

Mexico and the aerospace industry

The aerospace industry in Mexico has grown almost 19% annually since 1994; it is the America's most competitive country in terms of aerospace manufacturing costs. Here are some statistics:

- Mexico is the sixth aerospace supplier to the United States.
- General Electric, the leading producer of aircraft engines in the world, has its largest Center for Research and Design outside of the US and Canada, in Queretaro.
- There are 270 aerospace companies and supporting entities (2012): 80% engage in manufacturing while the remaining 20% focus on design and engineering, as well as maintenance, repair and overhaul. **ProMéxico**

World Economic Forum, Davos Switzerland 2014

Mexico a country on the rise





President Enrique Peña Nieto attended the annual meeting of the World Economic Forum (WEF) in Davos, Switzerland on January 23-24. The forum focused on "The Reshaping of the World: Consequences for Society, Politics and Business."

Due to the importance of the transformations underway in Mexico, President Peña Nieto was a keynote speaker at this year's World Economic Forum. He presented his administration's plan and the structural reforms adopted in Mexico in the forum: Transforming Mexico.

Among heads of state and government, leaders of international organizations, as well as leading global companies with operations in Mexico, President Peña Nieto stated that over the past year, his government promoted a reform agenda to boost productivity, investment, economic growth and employment, which will provide the Mexican state with a new legal and institutional framework.

On February, during the Second Congressional Congress will move forward in the implementation of the approved reforms, which seek:
