LETTER OF INTENT REGARDING BILATERAL COOPERATION BETWEEN THE GOVERNMENT OF THE UNITED MEXICAN STATES AND THE GOVERNMENT OF SAINT VINCENT AND THE GRENADINES

The Government of the United Mexican States and the Government of Saint Vincent and the Grenadines, hereinafter referred to as "the Signatories;"

CONSIDERING the deep ties of friendship and cooperation existing between both countries;

TAKING INTO ACCOUNT that both countries have maintained a permanent dialogue with the agreement of actions with the purpose of contributing to the development of the Caribbean region;

RECOGNIZING their interest in generating opportunities to strengthen cooperation between Mexico and Saint Vincent and the Grenadines, seeking to improve the living conditions of both peoples;

AWARE that both seek to safeguard collective memory and strengthen regional identity through the promotion of archival activities, with the purpose of generating solid mechanisms for the preservation, arrangement, organization and safeguarding of documentary and graphic collections that should be preserved due to their high substantive, historical or cultural value;

BEARING IN MIND the provisions of the Basic Agreement for Scientific and Technical Cooperation between the Government of the United Mexican States and the Government of Saint Vincent and the Grenadines, signed in Washington, D.C., United States of America, on August 9, 2007;

DECLARE THEIR INTENTION TO:

- Carry out joint efforts in order to carry out international cooperation initiatives for development, tending to the achievement of projects, actions and programs to preserve, disseminate and increase the documentary heritage of the Signatories with the objective of safeguarding the collective memory and strengthening their national and regional identity.
- 2. To allocate international cooperation resources to implement mechanisms for the preservation, arrangement, organization and safeguarding of the collections, in accordance with the best international practices of each of the Signatories.
- 3. To recover historical archives in the Caribbean that strengthen the collective historical memory, therefore the Signatories will share among themselves those documentary or graphic findings that, due to their high substantive, historical or cultural value, result in the interest of any of them to preserve them in order to increase their documentary or graphic heritage. To promote the corresponding executive actions for the development and achievement of the projects, actions and programs that may derive from this Letter of Intent, promoting the principles of relations with the Central American region that have characterized Mexican-Vincentian cooperation.

In order to coordinate the actions that will be developed based on this Letter of Intent, the Signatories designate the following authorities:

- for the Government of the United Mexican States, the Ministry of Foreign Affairs (SRE), through the Mexican Agency for International Development Cooperation (AMEXCID); and
- for the Government of Saint Vincent and the Grenadines, Mrs. Kay Martin-Jack, Chief Education Officer, Ministry of Education and National Reconciliation.

This Letter of Intent is signed in the City of Kingstown, Saint Vincent and the Grenadines on the 19th of April 2023, in two original copies in Spanish and English, both texts being equally valid.
